BRIEFING & CONDITIONS FOR PARTICIPATION

Category A

Briefing "illustration(s) – 1m x 1m"

Participation in this competition requires the participant's unequivocal agreement with these rules and regulations. Participation is **free**.

- Art.1. The illustrator has at least two publications in his/her/their portfolio (published material should included). New material may also be submitted.
- Art.2. Entries should not be framed (same for 3D). A passe-partout is allowed. During the exhibition the illustrations will be presented under plexi (done by us), available space: 1m on 1m.
- Art. 3. An entry cannot have more than six illustrations unless they are part of one whole artistic work. They will be displayed on a surface of **1m** x **1m**.
- Art.4. For a smooth follow up, the exhibits/entries should be wrapped securely with your name clearly visible on the package. Please also provide a small outline of how the display (1 sq. m) should look like. The submitted illustration(s) should be accompanied by a fully completed participation form and insurance document. The name of the illustrator (in capitals) should also be clearly visible on the back of the art work.
- Art.5. The entries for the exhibition are expected between January 3rd January 17th 2024. They can be delivered during opening hours at CC De Ververij Wolvestraat 37 at 9600 Ronse, Belgium (Tel. 0032(0)55/232801). Opening hours: Monday through Friday from 8u30 am to noon, and from 1:30 pm to 4 pm CET.
- Art.6. The entries should be picked up at the latest on May 3rd 2024 at the above mentioned address. Those works that are not collected will become property of the City of Ronse. Art works will not be returned by post.
- Art.7. The organizers retain their right to make a pre-selection of contributed works. The entries will be submitted to a professional jury. The decisions by the jury are indisputable. There will be no written or email communication about the competition or the jury decision. The selected illustrators will be individually informed by email.
- Art.8. The winner will receive the PRESTIGE AWARD 'Picturale' 2024 as well as:
 - € 2500
 - His/her/their creation/illustration will be permanently displayed as a mural in the centre of Ronse
 - A unique solo-exhibition at the beautiful space of CC De Ververij

The winner will be announced at 5:30 pm during the festive opening event (vernissage) on Saturday February 17th, 2024.

- The winner of the PUBLIC PRIZE in category A will be announced during the closing event (finissage) on Saturday March 30th and will receive Euro 750.
- Art.9. All of the works selected by the professional jury will be displayed during the 10th 'PICTURALE' 2024. The illustrator agrees to renounce his/her reproduction rights once so that they can be published in the catalogue or digitally.
