BRIEFING & CONDITIONS FOR PARTICIPATION

Category B

Participation in this competition requires the participant's unequivocal agreement with the conditions for participation. Participation is **free**.

Briefing illustrations 50cm x 50 cm

- Art.1. Only illustrators who did not yet publish any work (or maximum 2 works) can participate. Each candidate can submit only 1 illustration/document measuring 50cm x 50cm.
- Art.2. The participant will design to his/her best abilities an original illustration to **the theme required by the organisers**. The participant has complete freedom with respect to classification as well as the number of images used. The theme of this edition is **FABULOUS FAMILIES**.
- The submitted document/page should be framed in a passe-partout (to secure the illustration when hanged). The choice of techniques is free.
- Art.3. For a smooth follow-up, the exhibits/entries should be wrapped securely with your name clearly visible on the package. The artwork should be accompanied **by a fully completed participation form and insurance document. The name of the illustrator (in capitals) should also be clearly visible on the back of the work.**
- Art.4. The entries are expected between January 3rd-17th 2024 and can be delivered during opening hours at CC De Ververij – Wolvestraat 37 at 9600 Ronse, Belgium, (0032 (0)55/232801). Opening hours: Monday through Friday from 8u30 am to noon, and from 1.30 pm to 4 pm.
- Art.5. The entries should be collected by May 3rd 2024 at the latest at the above mentioned address. Entries that are not collected timely will not be returned by post.
- Art .6. The organizers retain their right to make a pre-selection of contributed works. The entries will be submitted to a professional jury. The decisions by the jury are indisputable. There will be no written or email communication about the competition or the jury decision. Selected illustrators will be individually informed by email.
- Art.7. The winner receives the **PUSH 'PICTURALE'! 2024** Prize which includes
- € 1000
 - and he/she will be commissioned to provide an illustration that will be published
- The winner will be announced at 5:30 pm during the festive opening event (vernissage) on Saturday February 17th, 2024.
- The winner of the PUBLIC PRIZE in category B will be announced during the closing event (finissage) on Saturday March 30, 2024, and will receive € 300.
- Art.8. All of the works selected by the professional jury will be displayed during the 10th 'PICTURALE' 2024.
- Art.9. The illustrator agrees to renounce his/her reproduction rights once so that they can be published in the catalogue or digitally.

3. **For the catalogue:** please submit a digital version of your illustration to waldo@postvorm.be (deadline = 31 January 2024). Technical specifications: minium 300 dpi, TIFF, EPS or jpg.
